Dissertation: "Differences Between African-Americans and Whites in Migration to the United States South, 1955-2000."

Description: Using IPUMS data and a nested logit model, I show that African-Americans' likelihood of interstate migration - both total and return - has increased dramatically over time, and grown increasingly similar to that of whites. This pattern holds net of origin and destination factors, individual characteristics and distance. Further, despite its history of racism, the South has become increasingly attractive for African-Americans compared to the rest of the country.

Working with Marianne Hillemeier and Pamela Farley Short at the PSU Department of Health Policy Administration and the Population Research Institute, I programmed a simulation of Medicaid and SCHIP health-insurance eligibility, based on data from the Survey of Income and Program Participation.
